John Gainor is the former President and Chief Executive Officer of International Dairy Queen, Inc. (IDQ), a Berkshire Hathaway company. Gainor served in this role from July 2008 until his retirement at the end of 2017. He was responsible for overseeing all aspects of this \$4.5 billion-dollar brand which included 6,900 restaurants in the Dairy Queen, Orange Julius and Karmelkorn systems throughout the United States, Canada and 28 other countries. In 2015 Gainor was a recipient of the Golden Chain Award by Nation's Restaurant News, an award that celebrates the best leaders in the restaurant industry selected for running industry leading operations, mentoring top teams and creating opportunities for others.

Gainor began his career with IDQ in September 2003 as Chief Supply Chain Officer for Unified Supply Chain, Inc., a wholly-owned subsidiary of IDQ. He oversaw the management of all supply chain functions for IDQ including purchasing, logistics, distribution, dairy, frozen novelties, equipment and supplies.

Prior to joining IDQ Gainor held various executive positions in the food service industry.

He was the President and co-founder of Supply Solutions, Inc., which designed and implemented supply chain and logistics solutions for national chain restaurants. His background includes working with franchisors as well as the distribution side of the quick-service and casual dining restaurant industry.

He serves on both the Audit Committee and chairs the Nominating and Governance Committee with Saia, Inc.

Gainor also currently serves as a Director on the Board of Jack in the Box Inc. (NASDAQ: JACK), one of the nation's leading fast-food hamburger chains with more than 2,200 quick-service restaurants in twenty-one states and Guam. He serves on both the Compensation and Nominating and Governance Committee with Jack in the Box Inc.

Gainor was elected in 2019 as a National Trustee on Ohio University's Board of Trustees and is a member of the Academics and Student Success Committee and the Governance Committee.
